Our Year

Chairman's Report for the year ended 31st December 2019

I became the new Chair of CPRE Sussex during the AGM in the summer of 2019. I was new to CPRE and quickly discovered the wealth of talent that could be drawn on to address the many pressures Sussex is under. It was also clear that we could only continue to address our purposes if we reinvigorated our fundraising so that we could continue to deliver our purposes for the people and diverse communities of Sussex.

This was some of the work we did in 2019 and we will put in place a new Strategic Plan to focus our work on key areas. We will also examine how we can work best as a team and engage new members and Trustees fully in our work.

I am most grateful to the staff of CPRE Sussex and the Trustees who have done a lot to make the past year a success and supported the efforts of this newcomer.

Climate Change

We joined the South East Climate Alliance (SECA) and joint-organised a Climate Emergency Summit in October 2019, a weekend event held in Shoreham-by-Sea which explored the issues relating to climate change and what is needed to protect the environment, health and well-being. The Summit was organised through a partnership of CPRE Sussex, the

EYE project which works to develop sustainability in schools, Shoreham Wordfest, the Ropetackle Arts Centre and featured talks from the National Climate Change Committee, CPRE Sussex, Sussex Wildlife Trust, Green Alliance and involved students from Shoreham Academy and YouthStrike4 Climate along with the wider public. It bought together MPs, councillors, officers, local people, universities and activists.

Planning

We evaluated the Chichester Local Plan and responded with concerns about the amount of development next to the AONB. With much of the District within the National Park, a large amount of development is planned for the South of the District and this will put huge pressure on the infrastructure and the natural environment.

We evaluated and commented on the draft Wealden Local Plan. Our main concern was whether the new plan would harm the Ashdown Forest and the High Weald Area of Outstanding Natural Beauty.

In Arun we held an affordable housing conference to examine the challenge of building the affordable houses we need. Michael Warden, who leads CPRE's work in Arun District, welcomed attendees and acted as chair for the event, supported by Ron Hurstwaite also from CPRE Arun. With a fantastic line up of speakers, the event received excellent feedback and will inform

future campaigns.

In Horsham we continued to campaign against unsustainable development, including the Horsham Incinerator. We began work on the Local Plan review, which will consider several new major development sites. We evaluated and commented on the Crawley Local Plan.

In Brighton we submitted comments in relation to Toads Hole Valley and other sites on the 'urban fringe.'

We evaluated and commented on the Worthing Local Plan, our main concern being the loss of valuable 'green gaps' and potential harm to wildlife sites.

Our Lewes group considered the latest iteration of the Local Plan and also organised a well-attended event at Firle, raising money for the village school.

In Mid Sussex we made a submission to Mid Sussex District Council (MSDC) on its draft Sites Allocation DPD arguing that with 60% of Mid Sussex designated as National Park or AONB or SSSI, there is an environmental constraint on the District's capacity to absorb ever-more housing, especially in terms of absorbing overspill from neighbouring districts.

In Rother we commented on the Revised Development Site Allocation Plan and continued to campaign for locally-led neighbourhood plans and against harmful development, such as a proposal



for 169 houses on the outer edge of Bexhill at Spindlewood Drive, immediately adjacent to the Ramsar site of Pevensey Levels, whose environmental classification is of international calibre of wetlands.

We responded to the Government's consultation about making a 'net gain' in biodiversity through planning mandatory. We also produced our own guide for how to include biodiversity in new developments.

We submitted comments to the' Glover Review' looking at the future role of our National Parks and Areas of Outstanding Natural Beauty. We are pleased that in its interim findings, Glover has taken on board the key points made in our submission that AONBs in particular need constitutional strengthening, a broader brief and additional funding if they are to play a similar role to national parks in keeping our most precious landscape assets environmentally fit and protected for future generations.

In terms of hydrocarbon extraction, we considered and responded to an application to extend flow testing at Balcombe, arguing that scientific and regulatory developments, especially with regard to climate change impacts, have significantly altered the planning balance judgement since the last approval. We also had concerns that the applicant needs sufficient financial resources to honour the obligation to restore and ensure adequate long-term aftercare to the site.

Our Year

Chairman's Report for the year ended 31st December 2019

Transport

As part of the South Coast Alliance for Transport and the Environment (SCATE) we met with Transport for the South East to share our report 'A New Direction' which explains why we need to move from the 'predict and provide' approach to continued roadbuilding and toward investment in sustainable transport. We evaluated and commented on plans for the Arundel Bypass.

As part of a network of CPRE branches, we co-ordinated a response to the government's Aviation Green Paper and produced a report which examines the environmental costs of aviation expansion. The report shows that people are becoming more sensitive to aircraft noise. It also shows that carbon emissions from aviation are making a significant contribution to climate change. We now want the government to ensure that aviation expansion does not allow us to exceed climate change targets and to monitor and manage noise at lower decibel levels than those currently used.

New Brand and Vision

We created a team to help us develop our new 'vision,' strategy and website, using guidelines developed by the National CPRE. We started work on the new website



Projects

We supported the CPRE national 'Star Count' in February 2019 and encouraged local people to get involved helping to map the skies in Sussex.

We launched the Plant Your Postcode scheme in Brighton & Hove. The scheme was created in response to requests from local residents to help them replace some of their city trees lost to disease and old age and to increase the tree canopy generally on their streets. We currently have around 30 groups/streets involved in the project. We have joined the Brighton and Hove Green Spaces Forum and are campaigning for more city trees through the new city Tree Strategy.

We met Homes England and urged them to ensure better community engagement in relation to the Northern Arc at Burgess Hill and to ensure that biodiversity 'net gain' and affordable housing are delivered throughout the development of over 3,500 homes.

We organised a litter pick along the A27 near Lewes as part of CPRE's 'Clean Green' in September. In addition to collecting a huge amount of litter, we highlighted the problem of litter on trunk roads and that Highways England should be responsible for clearing this litter, in addition to general road maintenance.

As part of a network of organisations we continue to lobby for the best use of the Downland surrounding Eastbourne and Brighton. We supported the request for 'rewilding' of golf courses on the outskirts of Brighton.

Staffing

We said a sad farewell to Sas Drury, our long-standing Finance Administrator and we welcomed Duncan Lyne to the team, who is proving to be a fantastic asset to CPRE.

Our invaluable Office administrator, Lesley Wilson, had a nasty fall from her horse in February resulting in serious injury and a lengthy hospital stay. Happily, Lesley has now recovered fully.

Tours Talks and Walks

Our wonderful volunteer, Lorna, organised a series of excellent tours and talks during the summer. Sadly, the visit to Malthouse Farm

was cancelled due to bad weather. The Tours and Talks are a great way for us to raise funds and for members to meet each other. Our Director, Kia Trainor, gave talks and presentations about our work to local communities including the 'Greening Steyning' group, The Goldstone Residents Association, the Wiggonholt Association, the Eastbourne Probus club and the conservative party policy conference. We arranged a visit to a low carbon 'Passivhaus' near Lewes for our planning volunteers. We attended the EYE Project (Eco, Young & Engaged) Eco Summit in Crawley with over 170 school children from across Sussex, focussing on environmental and sustainability issues. We organised a training event for anyone involved in planning which looked at 'good design.'

Fundraising.

We made a number of funding bids and successfully raised over £35,000 from grant-making bodies.
