

Annie Brown - **National Appointment**



Annie was appointed to the SDNPA in July 2020. She is a third generation family farmer on the South Downs, with a formal education in agriculture, business management and marketing. She lives in the Cuckmere valley on her husband's farm, and has overseen the strategic development of her family farm at Truleigh Hill since the inception of the National Park. She picked up the reins with mother and sister when her father died, and has overseen the delivery of a highly complex environmental stewardship scheme. The business has gained local and national recognition for its achievements in making space for nature while producing food. She feels passionately that the South Downs is a working landscape and that

traditional mixed farming practices – creating a mosaic of growing crops, grazing mixed livestock, wildlife corridors & field enclosures – contribute to the open rolling views that signify what we know and love about this landscape.

She is the lead farmer in the Eastern South Downs Farmer Cluster and is actively working with a group of farmers, land managers and stakeholders between Eastbourne and the Adur to improve the local natural environment at a landscape scale through co-operation and knowledge exchange. Based on the principle of "bigger, better, more joined up" this approach to land management is coming into focus with the development of the new Environmental Land Management Scheme.

She is vice Chair of the CLA South East committee, an active member of the local community in the Cuckmere, the NFU, the local agricultural society & the Local Access Forum for both Brighton & Hove City Council and the National Park and is keen to explore opportunities to reach out – to visitors to the Park, influencers, academics & researchers. Engagement is not traditionally in the tool box of many farmers, but never has there been a more important time to communicate beyond the farm gate, bridging the gap between urban and rural, working landscape and visitor, the importance of health and wellbeing, and an understanding of where our food comes from.

The structure of farming on the South Downs is fragile, and she is keen to champion the voice of the farmer and working landscape, to help protect and enhance the wealth of Natural Capital in the Park.

Tim Burr **National Appointment**



Tim was appointed to the SDNPA in July 2020. He has lived at Watersfield in the National Park with his wife Gillian since 2006. Tim was first elected to the SDNPA in June 2017 as a West Sussex Parish Member, and served on the five-Member Task and Finish Group that led the review of the Partnership Management Plan. Unsuccessful in the 2019 Parish Member election he lost his place as a SDNPA Member, but re-applied in 2020 and was reappointed as a Secretary of State Member. This persistence reflects a strong commitment

to the National Park, and especially to broadening its appeal across all sectors of the community.

Interests include British prehistory, in which Tim graduated from Southampton University post-retirement; cultivating Australian flora; and managing his 28 acres of National Park woodland. He was a volunteer on the SDNPA's Secrets of the High Woods project and, as an occasional stargazer, strongly supports its Dark Skies initiative.

Tim's career was in public finance, over more than 40 years, mainly in HM Treasury but with two spells in the Cabinet Office and concluding in the National Audit Office, ultimately as Comptroller and Auditor General. Reflecting this career path, he was – and now is again – a member of the Authority's Policy and Resources Committee.
