Dear Tim Loughton MP,

Stop the 'Mutant Algorithm' for the sake of Sussex

We are writing to you on behalf of CPRE Sussex, the countryside charity and the Sussex Wildlife Trust. Both charities campaign for a planning system that empowers local communities and protects and enhances the rich biodiversity of Sussex. A fit-for-purpose planning process has the power to ensure everyone has a decent home, that meets their needs and that they can afford. New homes should be inspiring and beautiful places to live, where people and nature thrive together.

David Johnson, CPRE Sussex Vice Chair, spoke to you at the recent Shoreham Farmers' Market and showed you a joint letter from Kent MPs. He conveyed your alarm and concerns at the current planning changes and their potential implications locally, particularly proposals contained within the consultation on 'Changes to the Current Planning System'

As you know, the proposed 'changes to the standard method for assessing local housing need' will change the calculation for how many new houses have to be built in each local authority area. We forward to you an analysis of the new housing targets to be proposed for the various Local Planning Authorities under these proposals. The analysis is from the planning consultants Lichfields but is forwarded to you from CPRE Sussex and the Sussex Wildlife Trust.

For Adur the proposed figures are (homes per year):

Current local plan target	177
Average build, last 3 years	97
Current 'standard method' target	248
New proposed new target	326

Meeting this target will require a substantial loss of our rural countryside and associated habitats and will result in unsustainable, car-dependent developments that do nothing to meet the Government's commitment to net zero. It is also plainly undeliverable when compared to the actual build figures. It is part of no housebuilders business model to build so many houses that you have to sell them at a discount and this was illustrated within the Letwin Review of 2018. https://www.gov.uk/government/publications/independent-review-of-build-out-final-report

That may be attractive to some Whitehall lobbyists but it will not be at all popular with your constituents.

We are delighted that you spoke at the recent parliamentary debate about planning reforms where Andrew Griffith, member for Arundel and South Downs, coined the term 'mutant algorithm.' We support your comments on the problems Adur will have in accommodating any further development unless it is located in the remaining green areas which have been evaluated and excluded from the Local Plan for reasons of flood risk, sustainability and coalescence of communities. Earlier this month, housing minister Christopher Pincher said the method set out in proposals "is not set in stone" and that the government would consider a "better methodology." We are asking all Sussex MPs to challenge the current proposals and put forward a positive vision for planning that can deliver on our collective economic, social and environmental objectives.

We would greatly appreciate working with you to raise these concerns further in Parliament, such as the debate on motions related to planning on Wednesday 30th September and would be happy to meet to discuss this issue further. We would be grateful if your office could email info@cpresussex.org.uk with some suggested times and dates and we can arrange a meeting with specialists on this topic from both our organisations.

We know that you feel passionately about the landscape and environment of your constituency, and we hope we can support you in defending it in the face of this unprecedented threat.
