

A NEW START

I am thrilled to have taken up the reins as the CPRE Sussex Director. It's such a privilege to be part of an organisation with such an extraordinary legacy: 50 years of protecting our beautiful Sussex countryside.

It's thanks to you, as a member, that we still have so much to enjoy. This spring I've been drinking in the sights, sounds and smells of the countryside. The bluebell woods, bees visiting blossoming orchards, peregrines soaring above cliffs, the cacophony of birdsong at dawn. I've admired an exhibition at Chichester's Pallant House, full of art inspired by the Sussex landscape.

I've cycled country lanes, walked meandering riverbanks, seen the moons of Jupiter, and even enjoyed one or two pub lunches on pristine village greens. That we still have all this beauty is a gift – one that you, by supporting CPRE, have given us.

A FUTURE IN THE BALANCE

But we should not let what remains blind us to what we have lost, or to the threats that place our countryside, landscapes and communities in grave danger. As we celebrate our 50th year, my job is to look ahead to the next 50 years and ensure we're fit to fight the coming battles.

Right now, the prospects are not good. As David Attenborough says, we live in one of the most nature-depleted countries in the world. The way we farm has been catastrophic for nature – and the greed of developers has squeezed what little space for nature remains.

Our rivers are full of human waste and farming runoff. For many the night sky is just an orange glow. The countryside is full of barriers – physical, financial, cultural – that stop many people from enjoying it. The climate crisis is turbocharging flooding here and displacing people from their homes around the world. To cap it all, the cost of living in Sussex has, for many, simply become unmanageable.

A PLAN FOR ACTION

For me, fixing this is our priority. That's why I'm planning to launch a series of campaigns, alongside a reinvigorated network of local planning volunteers.

As well as putting a stop to bad developments, airport expansion and government dictated road building, there's a critical role for us in planting more trees and hedgerows. In supporting well-located renewable energy, in bringing forward brownfield sites in our towns and villages for beautiful, genuinely affordable housing, in opening enjoyment of the countryside to more people, in backing nature-friendly farming, and in cleaning up our rivers and coast.

There's so much to do, and many opportunities for you to make a difference too, whether through volunteering your time and skills or supporting our work financially. I'm looking forward to working with you, as together we fight for a greener future for Sussex.

THAT WINNING FEELING!

We're only halfway through the year, and, as part of CPRE Sussex, you've already scored some big wins for the countryside.

Your support saw us, alongside a host of other brilliant campaigning partners, see off a huge proposal by leisure company Center Parcs, that would have devastated ancient woodland near Crawley. The Oldhouse Warren site, and its rare breeding birds, is now safe from the bulldozers. You can read more about this in the Chair's report on page 5.

The dedication of CPRE Sussex campaigners like you has also paid off when it comes to the Government's plans for road building. The proposed dual carriageway A27 Arundel bypass, which would wreck villages, damage wildlife and increase climate-harming emissions has been pushed back to the 2025-30 period. The Government has cited environmental and design concerns as the key reasons for the delay – a sign that pressure from residents, and a host of campaigning groups including us, is working. However, the threat has not gone away entirely, so we'll stay vigilant and continue to promote alternatives that will help tackle congestion in a much more local and people-friendly way.

Your collective letter-writing and emailing power ahead of this year's local elections also led to pledges from council candidates from different parties across Sussex backing our manifesto for a greener future. Published online ahead of the May polling day, the manifesto set out priorities and policies for Sussex councillors – and many of you used our toolkit to write to your candidates asking them to back our

ideas. The CPRE Sussex team are now working to meet with elected councillors to hold them to their promises! Turn to page 5 to find out more.

TREE PLANTING SUCCESS

Our Forgotten Places tree planting project finally ended in March after a herculean final period of work to design and plant herbaceous borders and a new orchard. On the Bristol Estate, a design by Helen Manson, of Hearts & Flowers, was chosen for more than 12,000 bulbs, shrubs and plug plants, planted over eight volunteer sessions. Meanwhile, Brighton Permaculture Trust lent us their expertise for a community orchard tree planting session.

Following a successful bid with Brighton & Hove Council's arboriculture team for Queen's Green Canopy and HM Commemorative funds, we have planted 110 trees on the Bristol Estate, as well as in Bevendean, Moulsecoomb, Woodingdean and Portslade.

We have also carried out a series of winter tree planting as part of our Plant Your Postcode scheme. In addition to this, we are undertaking an ambitious tree planting project in the North Laine area and supporting the Greening Hanover Project.

NOW IS THE TIME TO ACT ON ELECTION PROMISES

This year CPRE Sussex published an election manifesto. In it we called on candidates from all parties and none to commit to tackling five big threats to Sussex's countryside and communities

- Local people priced out of Sussex
- Climate breakdown
- Excessive and damaging development and intensive farming
- A lack of access to nature
- Pollution of our water, air and land.

Tackling these threats is a key priority for CPRE Sussex and now the elections are over we will be pushing all councils to support our ambition to shape a greener future for Sussex.

Our manifesto, which you can view online at cpresussex.org.uk/news/cpre-sussex-manifesto-for-the-2023-local-elections/sets out how this can be done.

In summary we are asking councils to:

 Provide local, affordable brownfield homes by bringing forward all possible brownfield sites for development. There are currently 700 brownfield sites across East and West Sussex which could be used to build more than 23,500 homes.

- Tackle the climate breakdown by leading a Rooftop Renewables Revolution, prioritising sustainable travel and embedding climate change considerations in all policy making.
- Fight excessive and damaging development and intensive farming by ensuring new developments take account of water use and encouraging naturefriendly development and farming practices.
- Make nature accessible to everyone by planting new urban trees and woodland, ensuring everyone is within a 15-minute walk of a nature-rich green space and expanding the 'right to roam' on councilowned land.
- Stop pollution of our water, air and land by campaigning against the discharge of raw sewage into our rivers and seas, addressing air and light pollution and supporting action to reduce the run-off of agricultural pollutants.

SEPTIC SUSSEX BY THE SEA SEWAGE AND POLLUTING OUTFLOWS

There's an urgent need for joined-up thinking that considers the cumulative impact of sewage discharge and factors this into development plans, including the calculation of housing targets and assessments of site suitability, and, as the following example demonstrates, the deciding of planning applications too.

Details of the inspirational Adur River Restoration Project, one of only 22 nationwide projects to receive funding (£500,000) from DEFRA, were made public by Horsham District Council on 10 October 2022. Forming an important part of the Wilder Horsham District initiative, the project 'aims to restore nature, reduce flood risks, improve water quality and boost biodiversity in the River Adur area', stretching 'from the Knepp estate to Shoreham, where the river meets the Sussex Bay restoration of the seabed and kelp forests along the Sussex coast'.

Meanwhile, a developer had submitted an application to build 1,500 dwellings on farmland at Southwater (DC/22/1916).

The applicant's Environmental Statement advised that the nearest point where 'capacity is currently available for reception of flows from the Proposed Development' is the Barns Green wastewater treatment works (Wwtw).

No mention was made that in 2021 storm overflows of untreated sewage and storm water from this Wwtw spilled 40 times, discharging into the adjoining Parson's Brook for a total of 252 hours (data published 2022).

Data published in 2023 reveals that, once again in 2022 storm overflows from the Wwtw spilled 43 times into the brook for a total of 410.85 hours, despite the prolonged period of drought: theriverstrust.org/key-issues

Parson's Brook is a tributary of the River Adur, and the Wwtw is located within the Adur West Water Body catchment, which has a 'poor ecological status', apparently due in large part to pollution from wastewater /sewage discharge.

Any additional foul water, especially in huge quantities, would surely worsen the catchment's poor ecological status, to the detriment of the Adur River Restoration project and potentially, too, the seabed and kelp forests along the Sussex coast.

Although withdrawn in February 2023, a further application to develop the site is expected.

CHAIRMAN'S REPORT

This has been a very busy year for all involved with CPRE Sussex. Members, supporters, project partners and a band of dedicated volunteers have once again helped shape a greener future for Sussex and protect our precious countryside and urban green spaces.

DEVELOPMENT PRESSURES

In 2022 we continued to fight to protect Sussex from inappropriate and unsustainable development. We have challenged District Plans and the Government's method of calculating housing numbers that does nothing other than suck development into the overheated south-east of the UK.

As always, this has been a collaborative effort. We worked with partners including the Sussex Wildlife Trust, The Woodland Trust, The Royal Society for the Protection of Birds, the Sussex Ornithological Society and Buglife, as well as passionate local campaign groups and our dedicated members, supporters and volunteers.

A co-ordinated response to the Center Parcs proposal attracted national attention. We challenged the company to find an alternative location and plant a new woodland rather than building in an Area of Outstanding Natural Beauty, on Ancient Woodland, right next to a Site of Special Scientific Interest. We now know Center Parcs has withdrawn its interest in the site.

We have also represented members' views in responses to a wide range of government and private-sector consultations on environmental matters.

We continue to closely monitor water quantity and quality issues, as well as campaigning with Sussex MPs, county-level authorities and district councils on several pieces of legislation threatening to remove or weaken environmental protections.

A GREENER FUTURE FOR SUSSEX

Guided by Interim Director Brian Kilkelly, we completed a review of our operational strategic direction. This led us to the view that, to protect and promote the countryside and urban green spaces, we must shape a greener future for Sussex.

This thinking will allow us to seek opportunities for Sussex's diverse communities to be more sustainable, as well as acting to protect the countryside and our valued heritage.

Thanks to those who make our work possible. I would like to thank our staff, volunteers, members, supporters and Trustees for your invaluable contribution to our work. Without your efforts and expertise, the charity could not exist and our victories would not be possible.

I would also like to thank the Trustees and volunteers who are stepping back from their roles – Trustees Stephen Hardy and Bill Freeman, planning lead for Mid-Sussex Michael Brown and Vic Ient, who has been a main mover in our work with the South Downs National Park.

Finally, we have recruited a new permanent parttime Director, Paul Steedman. Paul has extensive experience of working with member-based environment organisations. Many thanks to Brian Kilkelly for his inputs over the past year.
